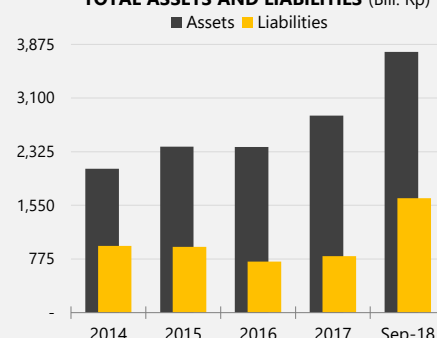

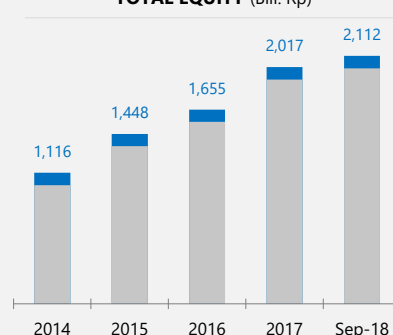

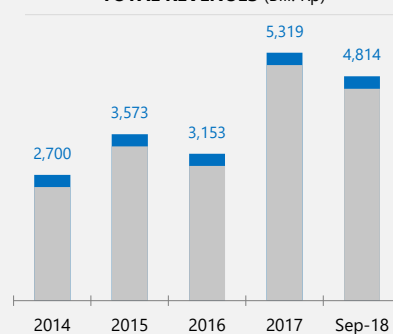
### TOTAL ASSETS AND LIABILITIES (Bill. Rp)
